1) **Register as the author** and thereby commit to the printing costs for your full paper if it is accepted for publication in JoDLA

If you have received the acceptance notification to submit a full paper, you are asked to **register as the author** for the next review stage at:

The author's fee for the publication is currently 400 Euros for the standard-length article of 8 pages. There is the option of publishing extra pages at 60 Euros per additional page. JoDLA is an open access journal and digital copies of all published articles will be available at <u>www.jodla.info</u>.

The author's publication fee includes one hard copy of the complete JoDLA volume. Additional hard copies are available for co-authors at a reduced price. Hard copies will be available at the DLA Conference desk; if shipping is required there is an additional 50 Euros fee.

2) Register as Speaker

The author(s) presenting the paper will also need to register as a speaker for the conference at:

The DLA conference fees for contributing authors to JoDLA are reduced.

3) Format and Standards for Submission

It is necessary to follow the **specified format and standards for the full paper**, which you will find at:

Publishing Guidelines for Journal of Digital Landscape Architecture

- ->-> Example [docx-File]
- ->-> Submission Guidelines
- ->-> Publication Ethics and Publication Malpractice Statement

It is important that the paper use the Word template: <u>Example [docx-File]</u> The publisher will only accept papers applying the layout of the Word template. For instance, this includes the fonts, font sizes, spacing and formatting for captions quotations and references.

Additional details on format the document and images for the publication are described in the **Author's Guidelines on Formatting Contributions.** For submitting the final version for printing, Full Papers accepted through the peer review process must also submit the original raster graphics for the publisher in TIFF, PNG or JEPG format with a minimum resolution of 600 dpi and the original vector graphics in PDF, EMF or WMF format or, if created using PowerPoint or Excel, as the original file.

The full paper is expected to meet the following standards, which will guide the peer-review evaluation of your full paper. Your work will have a greater impact if these standards are used as an outline for the structure.

- 1. Does your title properly reflect the subject of the paper?
- 2. Does the abstract provide an accessible summary of the paper?
- 3. Do your **keywords** accurately reflect the content?
- 4. Does the introduction clearly define the paper's topic and explain why the reader should be interested?
- 5. Are the objectives clearly defined and directly related to the topic from the introduction?
- 6. Do the methods directly respond to the objectives and are they clearly described?
- 7. What was discovered or confirmed? Are these **results** clearly derived from the described methods? The interpretation of the results should not be presented here, but in the discussion and conclusion sections.
- 8. Does the **discussion** explain the meaning and importance of the results? If there are limitations to the methods, are they discussed?
- 9. Are the **conclusions** based upon the results and the discussion of the work reported on, and not just a summary of the content? Is it clear from the conclusion whether the objectives were fulfilled, and what follow-on questions remain or additional work is indicated?
- 10. Are all **references** cited in the text and are they and the citations formatted as shown in the Example [docx-File]?

There are three additional standards upon which the paper will be evaluated:

- 11. Does the paper provide **new information** in the area of digital landscape architecture research, practice or teaching? Is there a relevant digital dimension to the work, and are there innovations in conception, methods, or results?
- 12. Are there sufficient graphics to support the paper's text? Are they readable at the scale of a printed page?
- 13. Is the text thoroughly **proofread?** It is recommended that a native English-speaker closely edit articles by authors for whom English is not their native language. This will improve the accessibility of your article and increase its contribution to the literature.

Please submit the full layout paper as a Word document by January 5 for the review of your full paper through the conference system. The identify the authors must be anonymous -- either omitted or blank them out:
